#### **MEMBERSHIP REQUIREMENTS**

#### 1. Active Members

- (i) Established Travel Agent (engaged in Ticketing, Cruise Services, Sales of travel related tour products, Inbound Services or Outbound Operating or General Sales Agent for air or sea carriers).
- (ii) Be a limited company whose paid-up capital is a minimum HK\$500,000 or Proprietorships/Partnerships who have to give a bank guarantee of HK\$150,000 to the Travel Industry Authority of Hong Kong.
- (iii) Have separate independent premises solely engaged in travel and tourism businesses.
- (iv) Having employed a minimum of 2 full-time staff, one of which has at least 2 years' experience in the travel industry.

### 2. Allied Members

Hotels or travel/tourist related companies who generally meet the criteria for Active Members.

- 3. The application must be sponsored by two Active Members and submitted together with the following documents:
  - (i) A letter by a certified public accountant company certifying that the paid-up capital of limited company is at least HK\$500,000 or a copy of bank guarantee of HK\$150,000 for proprietorships/partnerships.
  - (ii) A copy of the Memorandum and Articles of Association.
  - (iii) Copies of the Certificate of Incorporation, Business Registration Certificate, and Travel Agent's License Certificate (if available).
  - (iv) 3 photographs showing the entrance and the interior of the office.
  - (v) A cross cheque payable to "HONG KONG ASSOCIATION OF TRAVEL AGENTS LTD." for the appropriate fees as per the table below.
